I HEREBY ACKNOWLEDGE AND REPRESENT THE FOLLOWING:

1. I represent that I am under no physical impairment which should prevent me from participating in this event. If I am driving, I also represent that I am capable of meeting my responsibilities as a driver to safely operate the vehicle.
2. As it is my intention to waive and relinquish any claims which I might otherwise have against NAC, I represent that I have adequate insurances to cover myself, my passengers, and my vehicle.
3. I will not operate a vehicle while under the influence of alcohol or drugs; I will not operate while under the influence of any medications, over the counter or prescription, which would impair my ability to safely operate a vehicle.
4. I will obey all rules and regulations, whether written or verbal, including any instruction or direction from any NAC guide.
5. I will wear my seat and shoulder belt at all times that I am in my vehicle and make sure that all passengers do the same.
6. If I am a passenger, I will not distract the driver of the vehicle in any way which could interfere with the safe operation of the vehicle.
7. I agree that any photographs, pictures, videos or reproductions taken or made in connection with this event may be used in advertising, social media, and/or on the websites of NAC.
8. Leaving the event location is not permitted and NAC will not be responsible for non-event activities.
9. I understand that any misrepresentation herein, or any violation of the rules of this Agreement, including failure to obey any verbally given instructions or directions, will result in termination of my participation in the event, without refund.
10. I have a valid driver's license and I own (or have the owner's written permission to use) the vehicle which I will drive for this event.
11. My vehicle is street legal, and has valid state registration, license plates and state inspection for my home state.
12. My vehicle is currently insured.
13. I have inspected my vehicle; all equipment is in good working condition and has functional 4-low, a full-size spare tire (min. tire size: 31") functional and tuned GMRS radio, first aid kit, fire extinguisher and basic tool kit for my vehicle.
14. My vehicle is equipped with front and rear frame mounted recovery points (i.e. tow hook or 2" receiver insert), and it has a minimum of 8" of ground clearance.
15. If my vehicle requires assistance to leave from the event, I will be responsible for those costs.
16. No fluid leaks exist that would contribute to environmental contamination or fire risk. In the event my vehicle leaks any fluid, I will be responsible for all clean-up costs and repair of damage, if any.
17. I am aware of the risks inherent in driving, whether on or off road. I accept full and complete responsibility and liability for my actions before, during and after, and fully release and indemnify NAC for any injuries or damage caused by my negligent actions whether at a NAC event or not.
18. I understand that if I have made any misrepresentations herein, or if my vehicle does not meet these requirements, I may be prohibited from using my vehicle for the trail ride portion of this event, without refund.

I have read and understand the above requirements and representations, I understand the content and purpose for each, and I agree to abide by them.
